Terms and Conditions

Mountain Sports Distribution is the exclusive distributor of Snowpulse products within North America. The following terms and conditions must be agreed upon to be a dealer of Snowpulse products within North America. These conditions have been developed to ensure that all dealers make a profit from selling Snowpulse products. **Failure to comply with the terms and conditions detailed below may result in loss of dealership privileges.**

1. Dealers are responsible for all freight charges unless otherwise stated or negotiated.
2. Dealers may not advertise (online or in print) a price which is less than retail pricing before February 1st of each year unless permission is received from MSD for some sort of special event. Example: open house or tradeshow
3. In store a dealer may give no individual discounts of more than 5% before February 1st of each year. For group orders of 5 or more units a dealer may provide a discount of up to 10% per unit but no more.
4. If the retailer intends to ship a Snowpulse pack with a full canister, or an individual full cylinder, to a customer they must go through proper training and ship the package as a dangerous good. The package must contain all of the proper labeling and the shipping agency must be informed that they are shipping a dangerous good. This is to protect you as a retailer, should an incident occur. If you wish to ship please contact us for specific instructions.
5. Dealers must inform the distributor if they wish to sell online or in a different shop from the one listed above.
